Proiect Background:

- The building to the southeast of the project area was built in 2000 and renovated in 2019, both under the design of SOA Architecture.
- The building addition that the project area is within was built as part of the 2019 renovation and addition project, under the design of SOA Architecture and Timberlake Engineering.
- This project consists of minor interior demolition and new construction of an approximately 1,050 sf accounting
 office suite at the lower floor of the existing office building. The space being enclosed was previously open seating
 area. New work includes metal stud and gypsum wall board partitions, hollow metal frames, glazing, flush wood
 doors, carpet, acoustic ceiling tile, wall paint, HVAC reconfiguration, new lighting and electrical, and minor
 sprinkler system reconfiguration.
