Similarly, the law takes precedence over any oral statements made by a representative of PSRS regarding your rights, benefits and responsibilities as a PSRS member.

# PSRS: What's in It for You?

- PSRS retirement benefits are **paid for life**, no matter how long you live.
- Every dollar you contribute plus interest is **returned to you or a loved one** in the form of a monthly benefit or a lump-sum payment.
- **Financial protection is available** for your loved ones in the event of your death, both before and after you retire.

### What You Should Know Right Now

- PSRS membership is required by law for eligible certificated employees of PSRS-covered employers.
- Retirement contributions are deducted from your salary and paid to us by your employer each pay period. Your employer contributes an equal amount.
- Once you have five years of qualified service with PSRS, you are vested and can receive lifetime retirement benefits when you are eligible.
- PSRS is not like a 401(k), 403(b), 457(b), or IRA. Instead, your benefits are based on a formula set by law and not limited to how much you pay in (usually, you get more).

#### How We Help Fund Your Retirement

Your contributions, your employer's contributions, and the investment returns PSRS earns by investing those contributions all help fund your secure retirement future. Approximately 63¢ of every dollar paid to retirees is

generated from investment earnings.

### You are Protecting Your Loved Ones Right Now

Visit PSRS Web Member Services at **www.psrs-peers.org** to designate beneficiaries for pre-retirement survivor benefits. PSRS will pay these benefits if you pass away before retirement.

You can create and update your beneficiary designation by logging in to Web Member Services at **www.psrs-peers.org**. If you prefer, you can also do so using a *Pre-Retirement Beneficiary Designation* form, available on our website or from our office.

#### **Beneficiary Facts:**

- A sole, individual beneficiary is eligible to receive lifetime monthly benefits, which can be more advantageous than a lump-sum refund of your contributions and interest.
- Keep your beneficiary designations up-to-date so any benefits are paid according to your wishes.
- If you have a life-changing event, such as a marriage, birth of a child, or a divorce, you must file a new beneficiary designation or beneficiaries will be determined by Missouri law.

#### Other Membership Advantages

- **Disability Benefits:** If you develop an illness or sustain an injury that prevents you from working in any capacity, you may be eligible for PSRS disability benefits.
- Service Purchases: All members are eligible to purchase some type of service with PSRS before retirement. Purchasing additional service can help you achieve a higher benefit or reach retirement eligibility sooner.
- **COLAs:** Cost-of-living adjustments are given on service and disability retirement benefits when eligibility and economic requirements are met.
- **\$5,000 Death Benefit:** As a retiree, a one-time, lump-sum death benefit of \$5,000 is payable to the beneficiary you designate.

# A Note about Social Security

Most PSRS members don't contribute to Social Security, but you might be eligible for Social Security as a result of other employment or through a spouse.

Contact Social Security at **(800) 772-1213**, visit their website, or visit your local Social Security office to determine your eligibility.

#### Retirement is in Your Future – But When?

After 30 years of service under normal retirement, your PSRS benefit will replace approximately 75% of your pre-retirement income.

Your membership begins right now, but when can you retire? You are eligible to retire with normal benefits at:

- Age 60 with at least five years of service
- Any age with at least 30 years of service
- Rule of 80: when the sum of your age and years of service equals 80 or more

Early retirement options are also available, but benefits under these options are reduced.
